VII. Approval of Minutes of 2015 Meeting:

The 2015 "ABDPH Minutes of the 66th Annual Diplomates Meeting and Banquet" were posted on the ABDPH website. The 2015 Minutes and the ABDPH 2015 Actual vs. Budget -2016 Budget were provided as handouts for attendees.

VIII. Report of the Executive Director:

- A. Board Membership Status: As of December 31, 2015, there were 144 certified Active Diplomates, 43 Life Members for a total of 187 living Diplomates.
- B. Statistics on 2016 ABDPH candidates: Eleven candidates took the full or part of the examination; 24 candidates taking written examination including 1 taking full examination. No dentists will lose eligibility in 2017.
- C. Life Membership: As of April 27, 2016, there are 44 ABDPH Diplomates Life Members-Living. Dr. Alderman informed members to check the ABDPH website for the Application for Life Membership Categories, and the current Life Members.

IX. Report of Officers and Directors:

- A. Secretary/Treasurer's Report. Dr. Ana Karina Mascarenhas reported that the financial records were audited by Drs. Ana Karina Mascarenhas and Dr. Eugenio Beltrán, New Executive Director, at the Mid-year meeting in January 2016 and were accepted as accurate.
 1. The Board began the fiscal year on January 1st, 2016 with a net worth (Assets minus liabilities) of \$80,929. Total income for 2015 was \$41,876, which consisted of application and examination fees, annual registration fees, receipts for the dinner meeting, and certificates.
 2. Total expenditures for 2015 were \$49,647. 2015 Income minus 2015 Expense resulted in a \$7,772 decrease. Increase in travel expenses and ABDPH attendance at

the 2015 American Dental Association and AAPHD Midyear Meeting in Washington, DC and ABDPH Midyear Meeting in Fort Lauderdale, Florida. 2016 Budget is projected for \$5,293 net decrease: Income, \$56,362 and Expenses, \$61,655. The additional expenses of the Executive Directors' transition and increases in Board expenses are partially responsible for the deficit in the 2016 Budget.

3. As of April 02, 2016 ABDPH Check: \$67,672 including "ABDPH Dental Public Health Competency DentaQuest Project" \$32,061, Wells Fargo Money Market: \$48,582 for Total Assets: \$84,193.

Dr.'s Altman and Mascarenhas are leading the panel. DentaQuest funded a \$53,000 grant funding to support the process. Lotzkar funds will be used as necessary for the distribution of the results.
7. ABDPH Bylaws Change – During the mid-year meeting, the Directors passed changes in the bylaws, by which the Director-elect will be elected by all active Diplomates using electronic vote. A nominating Committee with representation of AAPHD and ABDPH will submit a list of candidates from those who had expressed their desire to be a candidate at the annual re-registration process. The Board will prepare and compete an election process by March 15 of each year. Dr. Don Altman, President, ABDPH is pleased to announce the Diplomates of the ABDPH have elected Dr. Athanasios (Thanos) Zavras as Director-Elect-2016. Congratulations Thanos!

ABDPH symposium, speakers and coordinators. **Tuesday, April 19th, 2016 – NOHC Plenary Session [Duke Energy Convention Center Jr. Ballroom A&B] 10:15 AM to 11:45 AM – ABDPH Plenary Session - American Board of Dental Public Health Symposium – Oral Health in Accountable Care Organizations -April 19, 2016 – 10:15 – 11:45 am; Julie Bluhm – Clinical Program Manager for Hennepin Health. A unique county-based ACO model of providing dental care through a partnership of four organizations; Gretchen Hageman – Director Dental Wellness Program, Iowa Adult Medicaid expansion. The Dental Wellness Plan uses an accountable care approach with the utilization of risk assessment and coverage tiers to provide dental care to the adult Medicaid expansion population; John J. Snyder, DMD – CEO and Dental Director of Permanente Dental Associates (PDA). PDA has been amongst the earliest adopters of an integrated approach to care delivery and is not a full ACO, but contains many of the ACO characteristics. Dr. Jeffrey G.
